Shift towards plant proteins will gather pace over forecast period, with premiumisation returning as prominent trend throughout overall category
Processed fruit and vegetables faces limited growth options, forcing players to focus on rising dietary trends and convenience demand

- Private label likely to retain strong competitive edge, and story-based marketing will become more prevalent
- Animal welfare concerns set to intensify though sharpened health-focus encourages greater scrutiny of substitutes' ingredients
